# CMS-HCC V28 2025 updates

The CMS-HCC V28 updates bring significant changes to the risk adjustment model, impacting Hierarchical Condition Categories (HCCs) and their associated Risk Adjustment Factor (RAF).

## CMS-HCC V28 2025 updates

The CMS-HCC V28 updates bring significant changes to the risk adjustment model, impacting Hierarchical Condition Categories (HCCs) and their associated Risk Adjustment Factor (RAF).

### **Risk Adjustment Factor impact**

The following coefficients were constrained (meaning they have the same RAF)

- HCCs 36, 37 and 38: Diabetes
- HCCs 224, 225 and 226: Congestive Heart Failure
