# New benefits

# **PriceMyMeds**

Available to commercial group and individual members

Launching in early 2024, PriceMyMeds is a new pharmacy program available to our members that helps them save on prescription medications. When a member's prescription is filled at a pharmacy, PriceMyMeds automatically searches for and applies savings opportunities, when applicable. In instances where members utilize the PriceMyMeds app to locate a better price at an alternative pharmacy, PriceMyMeds will provide instructions on how to 1) ask for a price match or 2) ask for a prescription transfer. All this with no effort from the provider, aside from occasionally sending the prescription to a new pharmacy if the member's current pharmacy doesn't accommodate transfers. PriceMyMeds is a key part of our ongoing goal to better support our members in getting the care they need by making sure prescription drug costs are not a barrier to care.

# **Continuous glucose monitor update**

In 2024, continuous glucose monitors (CGMs) and CGM supplies will be a pharmacy-only benefit and will no longer be covered at DME suppliers. There will be no changes to other diabetic supplies: test strips, syringes, insulin pumps, etc.

# **RSV vaccines**

We're now covering the Arexvy and Abrysvo vaccines, as well as the new Beyfortus monoclonal antibody treatment, under our members' preventive benefit.

Priority Health members who are 60 years old or older\*, pregnant, or 0–19 months old<sup>†</sup> have access to these treatments at \$0 cost.

\*RSV vaccines are not covered by Medicare Advantage plans but are covered by Medicare Part D.

<sup>†</sup>Prior authorization is required for patients over 8 months of age.

# **Expanded price transparency**

Priority Health has been providing cost-sharing information to members with our Cost Estimator tool since 2014. Beginning January 1, 2024, prices will be listed for *all* procedures and services covered under the terms of the member's plan\*.

Providers can use the Cost Estimator tool too.

Log in to prism and select "Cost Estimator" from the Resources menu. You'll be able to see what your patients see and what their out-of-pocket costs are for items and services.

\*Cost Estimator is not available for Medicare members.



# Commercial group products

### Core benefit updates

#### Behavioral health vehicle transport

Certain ambulance services recently introduced vehicles designed specifically for behavioral health transports. Priority Health will continue to cover behavioral health vehicle transports, including transports in the newly introduced behavioral-health-specific vehicles, between a facility and behavioral health facility, at the ambulance cost-share.

#### Breast cancer screenings for men

Beginning on January 1, 2024, we'll cover at \$0 cost share preventive breast cancer screenings for men with a family history of breast cancer under our preventive care benefits. Diagnostic breast cancer screenings for men continue to have a cost share.

#### **Employer group weight loss medication options**

We're now offering rider coverage for commercial group plans to cover certain lower-cost weightloss drugs (for various member cost shares, depending on the plan). Step therapy is required for some medications. This rider does not include GLP-1 type medications, although an enhanced version is available to self-funded groups to cover Saxenda and Wegovy.

# Southeast Michigan Network



# **Priority**Medicare products

### Updated benefits

#### **OTC allowance**

All PriorityMedicare plans now include an over-the-counter (OTC) allowance.

### Expanded transportation benefits (available on certain plans)

We've expanded transportation to 40 miles per one-way trip for Priority Health Medicare members.

#### **Discontinued Kroger partnership**

We've ended our partnership with Kroger. The plans that included Kroger-based benefits have been renamed to PriorityMedicare Thrive (PPO) and PriorityMedicare D-SNP Advantage (HMO). Kroger Pharmacy will now be considered out-of-network.


### **Enhanced benefits for D-SNP members**

Dual-eligible special needs plans (D-SNP) will now include a PriorityFlex card (more on the next page) and \$0 Part D drugs across any tier. *Member must receive Extra Help (Low-Income Subsidy) to qualify.* 

# Annual wellness visit update

### You asked, and we listened.

We're pleased to announce that annual wellness visits (AWVs) for Priority Health Medicare members can now be scheduled once per calendar year, giving more flexibility to see your patients when it works best for both of you.

# New PriorityFlex



Helping members pay for over-the-counter costs, healthy foods, select utilities (water, gas, electric, septic, trash, internet and phone) and pest control services.

- Included on both **Priority**Medicare D-SNP and **Priority**Medicare D-SNP Advantage.
- Members qualify for this benefit if they have any level of Low-Income Subsidy (LIS).
- The PriorityFlex card will be a Visa card, with which members can purchase items and services and pay bills at participating retail stores, through mail order or over the phone.

### Expanded options for OTC & OTC Plus

#### Over-the-counter allowance

All of our plans include a monthly or quarterly allowance to purchase health-related products not requiring a prescription, such as cold and allergy medication, as well as additional health and wellness products such as bathroom safety bars, toothpaste, sunscreen, incontinence supplies, etc.

- Online or via mobile app
- Buy in-store at participating stores • Mail-in order

New this year: we've added obesity as a condition for members with OTC Plus to qualify for healthy food and produce.





# **Priority**Medicare products

### Medicare pharmacy updates

- \$0 cost-share on Part D drugs (all tiers) on both D-SNP plans for members who qualify for Extra Help (Low-Income Subsidy)
- Statin quantity limits added to align with FDA-approved labeling
- Prior authorizations added to GLP-1s to add a review for a covered diagnosis
- Multiple generic and biosimilar additions with minimal member disruption (Find more details about this and other formulary changes in our Provider Manual)
- Kroger pharmacies will be **moving out of network** for all Medicare products effective January 1, 2024

**New for 2024:** GLP-1s will require prior authorization for members when a claim for a covered diagnosis (Type 2 Diabetes) is not on file with Priority Health; Medicare does not cover these medications for weight loss.

### **Inflation Reduction Act changes**

- Insulin coverage is capped at \$35 for a one-month supply (both Part B and Part D).
  - Part B Members will pay 20% **UP TO** \$35. The member will never pay more than \$35.
  - Part D A one month supply of insulin will never exceed \$35.
    - If the copay is less than \$35, it will be the lesser copay
    - If the copay is more than \$35 or a coinsurance, the member will pay \$35 for a one-month supply.
- \$0 cost-share for all Part D adult vaccines.
- Expansion of Low-Income Subsidy (LIS or Extra Help) program expansion.
- Elimination of the 5% coinsurance for catastrophic coverage.
