### Don't delay: Transition from APCD to PGE today

As a reminder, the transition from All Payer Claims Database (APCD) files to Provider Group Extract (PGE) files is underway.

If you haven't yet made the transition to PGE, please do so before you lose access to the APCD files:

- ✓ Get set up to accept Secure File Transfer Protocol (SFTP) files from us, if you haven't already.
- ✓ Update your mapping to the PGE before APCD files are fully retired.

We'll continue to produce and deliver APCD files through the first quarter of 2025.

PGE files are now being delivered via SFTP on the 15th of each month to ACNs receiving APCD files. Note: We're addressing a record truncation issue with the PGE files that we anticipate resolving with the November file run.

### Updated PGE data dictionary now available

We recently made the following updates to the [PGE data dictionary](#):

- **Med Claim View tab:** Now includes the previously missing field 101 – PROF\_FAC\_FLAG, which states whether the claim is professional (P) or facility (F)
- **Member Elig View tab** Updated fields 54-56 to align the data dictionary with the raw file as follows:

Field	Previous data dictionary name/element	New data dictionary name/element
54	Provider group / PROV_GROUP	PCP name / PCP_NAME
55	PCP name / PCP_NAME	ACN PIP ID / ACN_PIP_ID
