#### Peer-to-peer update for Medicare inpatient acute authorizations

Effective Jan. 1, 2026, we'll offer peer-to-peer reviews (P2Ps) for Medicare inpatient acute authorizations before issuing a denial, rather than after. The window of opportunity for a P2P will be short, to comply with CMS-required turnaround times for expedited Medicare organization determinations. | Read More
